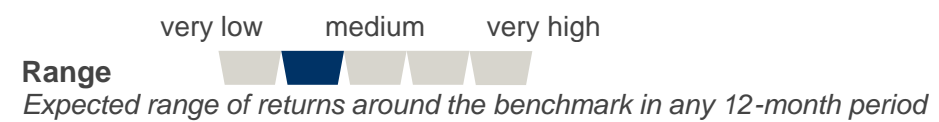
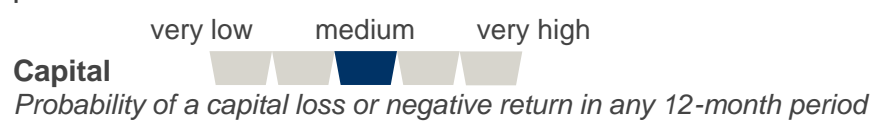

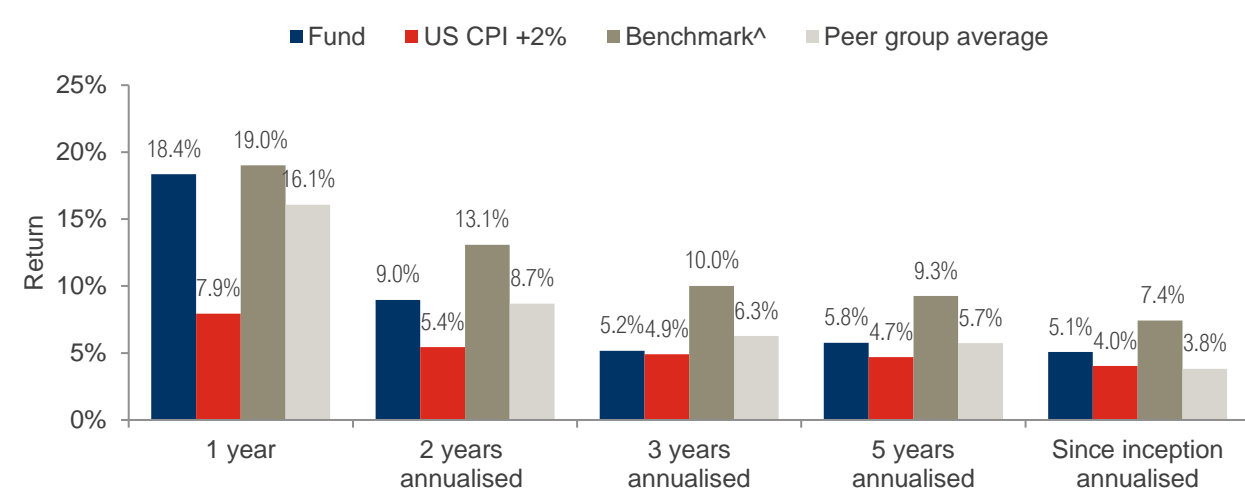

Investment objective

The investment objective of the fund is capital appreciation in real terms. The fund is ideally suited to investors with an investment horizon of 5 years or longer, and a moderate risk tolerance (measured in the Base Currency of the fund) over this period. The investment manager will tolerate short-term volatility in order to achieve the investment goal of long term real returns. The Fund intends to achieve its investment objective through a diversified global portfolio primarily consisting of investments in participatory interests of portfolios of collective investment schemes or other similar schemes.

[^] With effect from 01.07.18 the 30% allocation in the FTSE WorldBIG index was replaced with the ICE BofA Global Broad Market index. Both indices have had similar returns since the inception of the Fund and this change, which has not been applied retrospectively, has no significant impact on the performance comparison. The Fund performance is calculated on a total return basis, net of all fees and in US dollar terms. NAV to NAV figures have been used for the performance calculations. 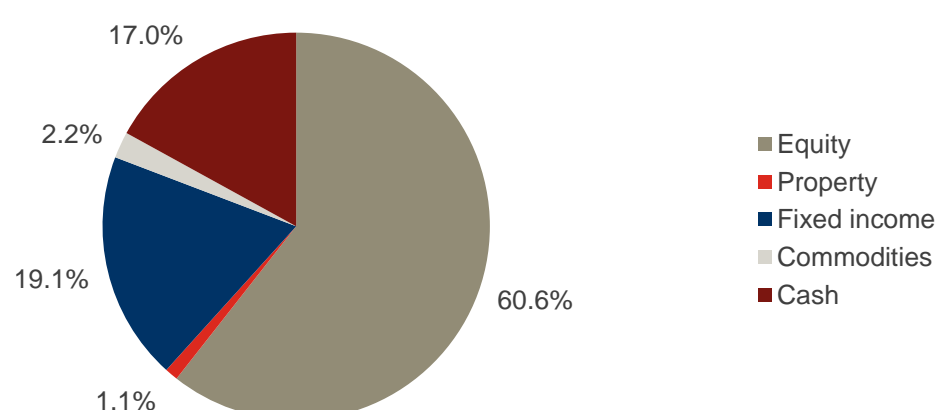

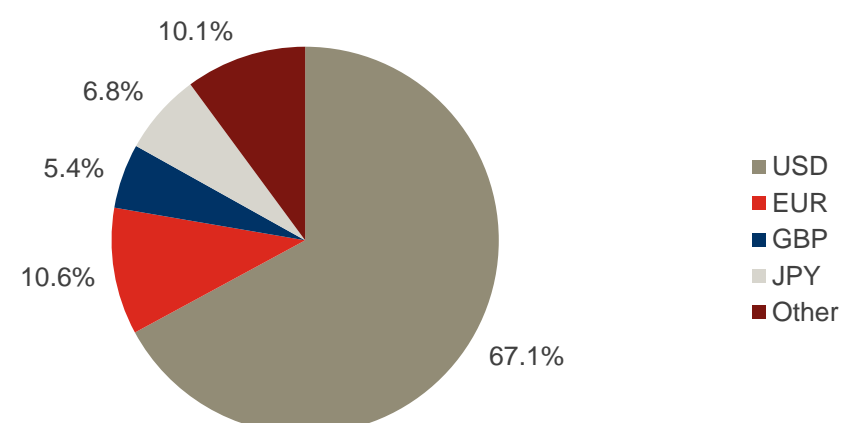

■ Market commentary

Global economic headlines remain focussed on inflation and potential tapering, as the global recovery moves ahead. US growth accelerated to 6.5% quarter on quarter and consumer confidence jumped back to pre-pandemic levels, while Europe saw stronger than expected 2% quarterly growth for the second quarter. The month was not without volatility however, with the Delta variant spreading globally, softer global economic data, US inflation moving even higher and Chinese regulatory interventions all leading to intra-month swings. Chinese regulatory changes caused some serious uncertainty and sell offs this month, especially in the share prices of tech companies. Global equities however rose for the sixth consecutive month and key developed market bourses again scaled new highs, buoyed by earnings surprises and lower bond yields. But emerging markets were materially lower when Chinese stocks recorded double-digit declines after the abovementioned regulatory intervention in the internet and education sectors.
